#### The following was discussed:

#### • 4x4 and Scrambler motorbikes

Major concerns were raised of the continual problem with scramblers and 4x4's on the cycle track and bridleway; dangerous to families who use the footpaths due to the speed in which the off roaders are going. Cllr Lewis advised that he recently witnessed one 4x4 drivers opening the gate with a key. It was noted that these concerns had been passed on to local PCSO Julie Banks, who confirmed that the person was known to the Police.

Sgt Bradley confirmed this is a constant problem which officers and PCSOs are trying to resolve. PCSO Julie Banks is also in the process of contacting all the motorbike clubs within the area to remind them that this behaviour is not acceptable.

#### Parking Issues

Concerns were again expressed of members of the public parking on the pavements on the junction of Castle Street and Bridge Street making it difficult for drivers to see when exiting from the junction.

Sgt Bradley confirmed this is a constant problem which officers and PCSOs are trying to resolve. South Wales Police have an active "Twitter feed" advising the public of the criminal offences.

The Licensing Department is consulting on proposed changes to the age policy guidelines and testing regime for taxis and private hire vehicles in Bridgend County Borough.
