Sgt Beynon updated Members on the crime figures for October 2018 comparing them to the previous year's figures.

Discussions ensued on :

- Domestic Violence – Senior and Primary Schools within the Town to be visited by a special Unit. It is hoped that this will help reassure young people what to do in situations of violence and to advise them on the help available.
- Air rifles; received feedback from members of the public, continue to monitor.
- Positive result on seizure of “Heroin” Drugs, Caerau. Investigations continue. Sgt Beynon requested that Members encourage residents to advise the Police of any concerns in this area; information will be kept confidential and anonymous .
- Further concerns were raised with the increase of motorbikes on the Llynfi Woodland Site and cycle track, with walkers being knocked over and assaulted by these youths; specific incidents were reported.

Sgt Beynon confirmed that these incidents are taken seriously; it is imperative that they are reported immediately “101” in order to get a patrol on site. If names of perpetrators known, important to report to the Police.

Members advised the locations used to enter the Cycle Track and relevant times these incidents occur. It was noted that parents are

seen regularly dropping off their children with their bikes at Maesteg Cemetery entrance.

Sgt Beynon confirmed that the Police are continuing to work with Natural Resources Wales to combat this problem; these issues will be addressed.

- Sgt Beynon confirmed that patrols continue to take place around Nantyffyllon Primary School to ensure no further incidents of trespassing, attempted burglary and damage; ASBOs have been issued. Continue to monitor. Reports received that youths moved on to other sites within the Village.
- Members were aware of the massive social media on the lead up to Christmas; the police asked that members of the public be more vigilant.
- Members were requested to continue to advise residents not to advertise on social media when they are away on holiday, as these messages are available to the local thieves.
- Camera, Caerau Square; enquiries still being made.

The Mayor thanked Sgt Beynon for his attendance.

171 **MAESTEG BUS STATION TOILETS**

In response to the Council's letter dated 6th September 2018 advising the Head of Neighbourhood Services, Mr Zachary Shell, of the decision that Maesteg Town Council is not in a position to take over the operation of the public toilets within the Maesteg Bus Station under a Community Asset Transfer and the suggestion made that the facilities be converted to "pay to use" similar to Bridgend Bus Station, the following reply received:

- Note the decision that the Town Council is not in a position to take over the operation of the public toilets within the Maesteg Bus Station under a Community Asset Transfer. Also noted the suggestion that the facilities should be converted to "pay to use" in a similar manner to those proposed for Bridgend Bus Station.
- Confirm that the decision to introduce "pay to use" facilities at Bridgend Bus Station was based upon the high footfall in users of the Station and current usage of the public toilets, which provided assurance that the re-configuration should be self-financing.

The public consultation and internal review undertaken by the Council did not suggest that this was the case at Maesteg toilets.

The Council has re-assessed the feasibility of introducing “pay to use” facilities, based upon the Street Works Team undertaking a monitoring exercise, since receipt of the Council’s letter. This has re-affirmed that the footfall and the level of usage of the existing facility would not enable the Maesteg facility to be self-financing.

As the day-to-day operation of the public toilets is not to be transferred, Bridgend County Borough Council will have no option other than to close the public toilets at Maesteg Bus Station, as previously announced, on 2nd January 2019.

187 **IRPW DRAFT REPORT (MINUTE 159)**

***Item 13 Payments to Members of Community and Town Councils
Maesteg Town Council – Group A***

Members noted the contents of the report.

The Clerk made reference to the following:

13.14 ***Determination 37*** – All Community and Town Councils must make available a payment to each of their members of £150 per year as a contribution to costs and expenses.

13.16 ***Determination 38*** - Community and Town Councils in Group A must make available an annual payment of £500 each to a minimum of 1 and a maximum of 5 members in recognition of specific responsibilities. This is in addition to the £150 payment for costs and expenses.

13.17 ***Determination 40*** – Community and Town Councils can make payments to each of their members in respect of travel costs for attending approved duties. Such payments must be the actual costs of travel by public transport or the HMRC mileage allowances.

Determination 41 – Community and Town Councils resolves that a particular duty requires an overnight stay, it can authorise reimbursement of subsistence expenses; at the specified rates on the basis of receipted claims.

Council has agreement in place to make the above payments to Members on approved duties.

13.18 ***Determination 42*** – Community and Town Councils can pay financial loss compensation to each of their members.

In the past Attendance Allowance was payable by Maesteg Town Council for Members undertaking delegated duties.

13.21 to 13.26 ***Determination 44*** - Provide a Civic Head payment to the mayor/chair of the council up to a maximum of £1500. This is in addition to the £150 payment for costs and expenses and the £500 senior salary if these are claimed.

Agreement in place that Mayor of Maesteg Town Council receives £1500.

Determination 45 – Provide a Deputy Civic Head payment to the deputy mayor/deputy chair of the council up to a maximum of £500. This in addition to the £150/£500 payments if claimed.

No payment made to Deputy Mayor of Maesteg Town Council.

It was noted that in previous years Maesteg Town Council agreed not to make payments for expenses and costs to its Members.

The Clerk confirmed that the current recommendations state that individual Councillors are to make the decision to decline a payment of £150 towards costs and expenses. This has to be in writing or by e-mail from the individual to the Clerk.
